

Little Missenden CE Infant School Safeguarding Statement

AIMS

At Little Missenden CE Infant School, we believe everyone in our school community deserves respect and kindness. It is the foundation of our school vision, founded on Ephesians 3:17, 'Rooted and grounded in love.' Through this we seek to nurture and support all within our school community, enabling them to take root and grow from the foundations of love in order to reach the fullness of their potential, flourishing and living lives displaying the values of friendship, thankfulness, honesty, forgiveness, compassion and trust.

We understand our pupils all come to us with different needs, backgrounds and experiences, and we place safeguarding as our paramount concern.

Safeguarding and promoting the welfare of children is the responsibility of everyone in the school community who come into contact with children and their families. In order to fulfil this responsibility effectively, this approach must be child-centred, always considering what is in the best interests of the child.

Safeguarding Children

At this Little Missenden CE Infant School, the health, safety and well-being of every child are our paramount concern. We listen to our pupils and take seriously what they tell us. Our aim is for children to enjoy their time as pupils in this school. We want to work in partnership with you to help your child achieve their full potential and make a positive contribution.

To promote a safe environment for pupils, our selection and recruitment policy includes all checks on staff and regular volunteers' suitability, including Criminal Records Bureau checks, as recommended by Buckinghamshire County Council in accordance with current legislation.

In accordance with our responsibilities under section 175/157 of the Education Act 2002, we have a Designated Person for Child Protection (the Headteacher) who has received appropriate training for this role. It is their responsibility to ensure that all staff in contact with children receive child protection awareness training on a regular basis.

There are occasions that our concern about a child may mean that we have to consult other agencies. Whilst we would always aim to work in partnership with parents there may be exceptions to this when concerns are raised for the protection of a child.



'Rooted and grounded in love' Ephesians 3:17 friendship, thankfulness, honesty, forgiveness, compassion and trust On very rare occasions Social Care, whilst undertaking an investigation under S47 of the Children Act 1989, may want to speak to a child without parents' knowledge. This would be a decision made in collaboration with partner agencies and would only be done in situations where a child might be at immediate risk. To gain consent at this point may increase the level of risk to the child or cause evidence of a crime to be lost.

The procedures, which we follow, have been laid down by the Local Safeguarding Children's Board, and the school has adopted a Child Protection Policy in line with this for the safety of all. If you want to know more about our procedures, please speak to the Headteacher.
